## OUR RESPONSE TO THE INFORMATION REQUEST UNDER THE 2002 ACT

For summary procedure cases in the Sheriff and JP courts, there are two different types of legal aid. Summary Criminal Legal aid covers cases where a Not Guilty plea has been tendered. Assistance by Way of Representation (ABWOR) covers summary cases which plead guilty or where the case is continued without plea. It was confirmed to SLAB on 6 May 2022 that you wanted both types broken down by
