

Payments over £25,000 - October 2021 to March 2022

Definitions

The following definitions are used in the listing of payments over £25,000:

- 1. 'Legal Aid Payments' are payments made to solicitors and advocates from the legal aid fund for the costs of legal aid cases.
- 2. 'Faculty Services Ltd' is the company which administers the majority of payments to advocates.
- 3. 'Payments to Assisted Persons' are payments made to people who have won their civil legal aid case and been awarded monies or property.
- 4. 'Expenses of Unassisted Parties' are payments made in accordance with Section 19 of the Legal Aid (Scotland) Act 1986.
- 5. 'Grant Funding Payment' are payments that the Board makes to fund targeted advice and representation services under a grant funding scheme agreed with the Scottish Government.
