I return this file after the taxation at Hamilton. At the end of the day no great point of principle was established. The Auditor was content to go with a daily rate of £1,125, but restricted the "commitment day" to £900. The consultation on 28 August and Note of 10 August were allowed in full, but the consultation on 22 October 2001 was restricted to £600. The preparation fee was restricted to £2,100. Finally, Mr Moir was allowed a fee of £100 plus VAT for attending at the taxation.

The Auditor expects us to deal with his audit fee directly with himself.

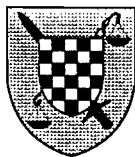
