Notes

This table shows what was paid to solicitors' firms between 1 April 2022 and 31 March 2023. Values are rounded to the nearest £1000. Fees paid comprise solicitor and solicitor-advocates fees. They include electronic payments transferred to the firms' bank accounts between those dates. In some cases, payments may have been returned to us, and any such amounts put through our accounts system between those dates have been deducted. Firms receiving payment from SLAB of less than £25000 have not been shown.

Where applicable monies paid back to SLAB in respect of audit restitution have been deducted in calculating the legal assistance fees shown.

The Correspondents' fees column shows the fees due to local solicitors where nominated solicitors instructed them to act. These fees are included in the sum for civil, criminal and children's legal assistance fees. To show the net fees paid to a nominated firm, correspondents' fees should be deducted from the nominated firm's fees.
